#### INTRODUCTION

#### WHO ARE WE

Marriotts Property LLP is a Limited Liability Partnership and Marriott Brown Ltd is a Limited Company, each of Chartered Surveyors. The Registered Address for both is 9 Market Place, Faringdon, Oxfordshire SN7 7HL, and Registration Number is OC384039. We are registered by RICS (004596 and 037597 respectively) and hold ISO Certificates of Registration ZA047600 and Z3036618.

#### HOW DO WE COLLECT INFORMATION FROM YOU

We obtain information about you when you use our website, for example when you contact us to enquire about a property.

### WHAT TYPE OF INFORMATION IS COLLECTED FROM YOU

The personal information we collect might include your name, address, email address, IP address, and information regarding what pages are accessed and when.

### **HOW YOUR INFORMATION IS USED:**

When you contact us via our website or engage us in a service we provide, or otherwise agree to our Terms and Conditions, a contract is formed between you and us. In order to carry out our obligations under that contract, we must process information supplied by you, and some of this information may be personal. We may use this in order to:

- send you details of property you have enquired about;

- carry out our obligations arising from any contracts entered into by you and us;
- verify your identity for security purposes;
- seek your views or comments on the services we provide;
- notify you of changes to our services;

We process this information on the basis there is a contract between us, or that you have requested we use the information before we enter into a legal contract.

Personal information relating to our service will be held on our systems for as long as is necessary for the relevant activity, or as long as is set out in any relevant contract you hold with us or as long as you have requested.

We are subject to the law and sometimes must process your information in order to comply with statutory obligations. For example, we may be required to give information to legal authorities if they so request or if they have the proper authorisation such as a search warrant or court order. This may include your personal information.

# WHO HAS ACCESS TO YOUR INFORMATION

- We will not sell or rent your information to third parties.
- We will not share your information with third parties for marketing purposes.

Third Party Service Providers working on our behalf: We may pass your information to our third party service providers, agents, subcontractors and other associated organisations for the purposes of completing tasks and providing services to you on our behalf (for example to send you mailings).

However, when we use third party service providers, we disclose only the personal information that is necessary to deliver the service and we have a contract in place that requires them to keep your information secure and not to use it for their own direct marketing purposes. ### SECURE SOCKETS LAYER (SSL)

When you give us personal information, we take steps to ensure that it is treated securely. Our website is hosted on a secure server and you will see a lock icon at the top of the page and 'HTTPS' in front of the page URLs.

The 'S' at the end of HTTPS stands for 'Secure'. It means all communications between your browser and our website are encrypted. HTTPS is often used to protect highly confidential online transactions but we use it to ensure all your data is protected.

#### **PROFILING**
